I know that athletic events are a potentially hazardous activity. I shall not enter and run in the Event(s) unless I am medically able and properly trained. I agree to abide by any decision of an Event(s) official relative to my ability to safely complete the Event(s). I assume all risks associated with participating in the Event(s) including, but not limited to, high heat and/or humidity, rainy or wet conditions, the conditions of the trails, all injuries or death that may be suffered by me before, during, or after the Event(s), all such risks being known and appreciated by me. I understand that the Event(s) involves mountain trails, away from medical services, and that there are rattlesnakes, mountain lions, ticks, poison oak, and other potentially dangerous and harmful elements in the area.
